Sturge-Weber syndrome (SWS) is a rare medical condition characterized by a facial Port Wine birthmark and varying degrees of glaucoma/and or seizure disorder. One or more of the following symptoms may result: seizures, developmental delays, glaucoma, paralysis, migraines, ischemic stroke, tissue overgrowth, endocrine issues, organ irregularities, and/or partial loss of visual field. As you can surmise, many doctors are involved in the treatment of SWS, those affected may never meet someone else with their disease, and no one's SWS is the same.

The Sturge-Weber Foundation's mission is to improve the quality of life for individuals with a port wine birthmark related conditions through worldwide education, support, and research leading ultimately to a cure. One of the programs supporting our mission is the biennial Sturge-Weber Foundation International Conference which brings together families, clinicians and scientists for a 2 ½ day conference. The disease is rare, the office staff is under 5 people, funding is under \$500,000 and the need for services is HUGE!
