I am writing to both acknowledge and commend the important work performed by Marisa Crame, Senior Director, Global Accounts at Helms Briscoe, for the Association of Black Sociologists. I am the Executive Officer of the Association of Black Sociologists (ABS) – a non-profit international professional organization of sociologists, social scientists, and social and political activists founded by women and men of African descent. The organization's mission is to build a tradition of scholarship that will serve Black people/communities in perpetuity and to create a powerful network of scholars who can be a direct catalyst for change in African American communities throughout the Diaspora and global communities of color. Growing out of the unrest and exclusionary practices in major professional organizations in the 1960s, ABS began as a Caucus of Black Sociologists within the American Sociological Association. From that time, through our incorporation as a professional organization in 1971, until today, we have grown as a strong professional organization, with members domestically, in the Caribbean and the UK, that gives voice to often marginalized scholars as well as to academic and non-academic social and political activists; we also publish a well-respected academic refereed journal: Issues in Race & Society: An International Interdisciplinary Journal.

As the Executive Officer of ABS, my many responsibilities include visiting various properties as potential sites to host our annual conference (AKA site visits). This is an important responsibility and involves a rigorous and systematic review of potential conference sites in various cities, contacting strategic sales persons at these sites, arranging a site visit and travelling to these properties, assessing the viability of a site for our annual meeting and its accommodations for our membership, making a recommendation to the ABS executive committee as to which property best meets our needs, and then negotiating and signing a contract and working with property representatives throughout until the end of our annual conference meeting. In selecting sites for our annual conference we have high standards which include our expectation that the site upholds fair labor standards and the highest level of environmental standards; have a clear commitment to diversity; have clean, spacious and adaptable meeting rooms to accommodate our meeting needs; offer a reasonable group rate to accommodate our membership which range from graduate students to retired professionals with varying economic resources.

Marisa Crame has done an outstanding job assisting me with this important responsibility. New to the role and responsibilities of Executive Officer and almost immediately confronted with having to move our planned annual meeting from Chicago to Las Vegas on very short notice in 2011, I was referred to Marisa Crame who, with her professionalism, expertise, hard-working demeanor and impeccable integrity, was a life saver. Within a very short period of time, she lined up several Las Vegas hotels and organized site visits for me. Moreover, she met me at each hotel and provided valuable assistance as I toured each property. Since that time, ABS has utilized Marisa's expertise every year as we plan our annual meeting and she has been nothing short of a highly knowledgeable and responsible professional, who has been proactive in finding and setting up sites of excellent quality for me to visit. As President Elect in 2012, I was responsible for organizing our Winter meeting in 2013. The planning for this meeting started in 2012. Our expectations of the meeting site selected are rigorous: we expect the site to uphold fair labor standards and the highest level of environmental standards. Each President-Elect sets additional criteria; I wanted to hold the meetings in a place that had a variety of pro-women state laws.
